Only deductibles and coinsurance which the Covered Person is responsible to pay will count toward the out-of-pocket cost. Other than deductibles and coinsurance, dollars necessary to be paid by the Covered Person for Optional Procedures as further defined do not satisfy out-of-pocket costs.</p>
